Old Business

Road Salt issues:

Wood talked to Ed Machowski about water testing data; he is working on a document for us. Wood is awaiting the completed data set regarding water testing already done in Norfolk, and will share with the group when she receives it.

Natural Resources Inventory 10 year update:

For addition to POCD, Anderson is asking for suggestions of new topics for updated NRI. The maps for the POCD are being updated; we will utilize some of the same maps as P&Z is using for the updated NRI, to save money. There may be differences between maps used in NRI vs. POCD such as zoning maps, but we need to update the ones that we will share. The maps we will share need to be the same for POCD and NRI. We may need to update vernal pool inventory for town. Maps should be updated for POCD by spring approximately.

Action Item: Anderson will ask Machowski to look at Aquatic Habitat map for any inaccuracies or changes.

Action Item: Wood will compare Aquatic Habitat with Critical habitat for consistency. **Action Item:** Klein will ask Borden to look at Protected and Managed land map for any updates/changes.

Action Item: Wood to ask Michele Sloan about 490 map for any changes or updates. **Action Item:** Klein will ask Havermeyer to check on changes to historic resources map and historic features of Norfolk Center.

Action Item: Anderson to check with Town Planner Glenn Chalder re: formatting maps so that there is consistency between POCD and NRI map- "Managed land and future land use".

Discussion of definition of managed open space.

Planning 2019 Activities:

Action Item: Anderson to confirm location of May 11 "Talk & Walk" event at the Hub, and Klein to do promotions. We are cancelling May 25 work day. We will be flexible regarding the follow up work day which should perhaps be postponed until June. Memorial Day weekend is not a good time for an outdoor work day.

June 8th Plant Exchange at the Farmer's Market:

Action Item: Wood will meet with Barry Webber of Norfolk Community Association regarding Village Green planting with native, pollinator friendly, low maintenance shrubs. Also a discussion of invasive trees on the Village Green (Norway maple, Sycamore maple) and potential management strategies.
