Invasive Plants: Nothing to report

Waste Reduction: Martha reported on an effort underway at DEEP to explore ways to reduce the waste stream burden by organizing a state wide effort [Connecticut Coalition for Sustainable Materials Management (CCSMM)]. It will examine the whole panoply of materials that get thrown out or "recycled" and how to lessen the amount of waste across the board. A series of workshops open to the public is posted on the DEEP website. Many municipalities have already joined this coalition and Martha has contacted Matt about the waste issue here in Norfolk but has not heard back yet. As for establishing a town-wide composting program, it was agreed we need more information about what people do with their food scraps and how much of our waste stream could be composted.

Action Item: Martha is reaching out to Blue Earth to see if they will do a presentation for us.

Action Item: Libby to reach out to Kelly Hughes re town waste reduction efforts

New Member: It was unanimously agreed to recommend to Matt Riiska that Mattie Vandiver-Pace be appointed as an alternate member of the Commission. She will receive official notification from Town Hall and then can call Linda Perkins to be sworn in.
