Present: John Anderson, Libby Borden, Shelley Harms, Martha Klein, Nash Pradhan, Sam Williams, Susannah Wood.

Meeting was called to order at 6:10 p.m.

A motion was made, seconded and approved unanimously to accept the minutes of the December 15th meeting.

**Correspondence:** There was a commission email concerning adding No Mow May to 2022 programs

**Public Comment:** None

**Budget:** There was a discussion of the 2022-2023 budget which must go in to Town Hall early in February. We will request the same amount as in 2021-2022. It was suggested to make a general heading of “programs” for activities other than invasive species control. For the remaining current budget year:

Nash will submit a bill for the \$80 cost of pollinator plants donated to Botelle.

\$900 is set aside for the NRI.

A motion was made to spend \$400 on additional 20 to 30 blue bird boxes and a few kestrel boxes for distribution around town. (moved-Shelley, seconded – Susannah, unanimously adopted).

**Road Salt Testing:** Nothing new to report. Susannah will submit data next meeting. Colebrook seems to be putting out a lot of salt, especially along Sandy Brook.

**Action Item:** Susannah to reach out to Colebrook Land Trust to give them a heads up

Waste reduction

**Invasives:** Could do something monthly in Norfolk Now, highlighting one invasive plant relevant to the season and how to best control it?

**Action Item:** Nash to get recent publication from NOFA on invasive control strategies

UMASS doing a presentation on invasive worms in our woodlands.

**Action Item:** Nash to send link

Another possibility would be a survey of invasives on town lands. Discussion of phragmites. A suggestion was made to see how the control effort in the City Meadow goes.

Liz Allyn of the UCC Green team wants to tackle waste reduction and to learn more about it.

**New Business:** Discussion of a letter to the Catholic church about removing invasives. There are 2 burning bushes and Norway maples, especially on the southern property line. Commission will consider financial aid to take out the big Norway maple.
