## Selectman's Report

- Annual Town Meeting to be held on Monday, May 8, 2023 at 7:00 p.m. at Botelle School. M. Riiska reviewed some of the items listed on the Call of the Meeting (tennis court refurbishment, fiber optic work in town, Botelle School roof and Maple Avenue reconstruction and remediation from gas spill).
- Regional #7 Referendum results 49 YES 14 NO
- Fuel Spill Reimbursement The Town of Norfolk submitted a request for \$172,000 in reimbursements from Federated Insurance Company and received a check for \$168,000. We have reimbursed all individuals and businesses that were effected.
  M. Riiska completed the paperwork for our next submission which is \$105,000.
- Frontier Fiber Optics The Town's cost will be \$467,000. To be discussed further at the Town Meeting.
- River Place Bridge The physical work is on hold while engineering work is being done. There is a problem with the footings on one side. M. Riiska expressed his concern to the engineers considering the bridge was scheduled to be completed 11/30/22. M. Riiska contacted Salisbury Bank and we have budget funds to take care of interest payments.

## Selectman's Report (continued)

- Summer Projects will include paving on Hillside Street (to be paid for by Aquarion Water Co.) and Laurel Way Ext. Distinctive Tree will be working around Doolittle and on Old Goshen Road. The sidewalks downtown will be redone from the Post Office to the Berkshire Store and Robertson Plaza to Route 44. Also spot paving and catch basin work will be done.
- Fuel Spill Informational Meeting will be held on Tuesday, May 23rd at Botelle School.
