2023 Activities:

Invasive plant outreach program: Bill to give a talk on invasive plants and how to remove them. Scheduled at the Hub on May 13th, Saturday at 11AM.

Free disposal of Invasive debris: Matt agreed to allow *Norfolk residents* to dispose of Invasive debris at the transfer station burn pile. Nothing over 3" in diameter. The fee is not waived for landscape contractors.

Threats to insects talk: Susannah to present a slide show at the Library on May 18th, Thursday at 5:30.

Farmers Market Plant exchange: Scheduled for June 24th.

NRI launch event: Develop plan for event, possibly in June.

Bluebird boxes: Boxes have been installed at the South cemetery. Shelly wants to install more at the Music Festival meadow. Permission from Yale still pending. There are budget concerns to resolve.

Friends of the Meadow: Multiple groups need to coordinate ongoing the efforts to make the meadow a useful attractive and welcome destination for the town. Plans for maintenance need to be addressed by Matt.

Tobey Pond Clean up: Susannah contacted Matt and Great Mountain Forest, the town crew has agreed to clean up the rope for the swimming area, which is disintegrating on the beach. A new rope will be acquired.
