

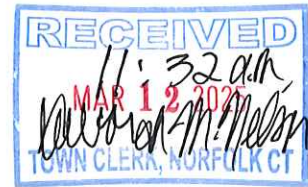
# NORFOLK BOARD OF ASSESSMENT APPEALS
