PUBLIC HEARINGS: 3.

Application #25-009 - Edward Hinman, 39 Schoolhouse Road Special Permit per Section 3.02.C for a Container Tree Nursery in the Rural Residential Zone.

Ms. Sefcik read the public hearing notice and showed the proof of notice to abutters.

Ted Hinman gave an overview of the application and answered questions the Commission had from the last meeting. Stacey Sefcik received no comment about the project. Wetlands determined it was a permitted use as of right. Jordan Stern made a motion to close the public hearing at 6:42pm, seconded by Steve Landes and approved unanimously. Steve Landes made a motion to approve the Application #25-009 -Edward Hinman, 39 Schoolhouse Road Special Permit per Section 3.02.C for a Container Tree Nursery in the Rural Residential Zone subject to the condition that truck traffic to and from the site not to exceed the amount estimated without additional approval from the Commission, up to 30 trucks per year larger than a pickup truck, and if the business changed Mr. Hinman would come back to the Commission, seconded by Jordan Stern and approved unanimously.
