1. **CALL TO ORDER & ROLL CALL.** 6:31 pm Chris Schaut, Chairman, Wiley Wood, Jordan Stern, Jonathan Sanoff, Stacey Sefcik, ZEO, Marinell Crippen, Recording Secretary, Marion Felton 6:40pm
2. **AGENDA REVIEW.** Wiley Wood made a motion to move number 3-Opportunity for public comment, to after new business, seconded by Jordan Stern and approved unanimously.

 - A. Informal Discussion with Kate Briggs Johnson Regarding Proposed Permitting Required for Proposed Renovations at 292 Mountain Road. Kate Briggs Johnson explained the project which is the Javits' property. The property is over 100 acres. There are multiple seasonal dwellings on the property including a garage, main house, upper house with studio space and lower house. There are none with year round heat. The lower house foundation is a mess. Ms. Johnson spoke about the regulations and thinks this is a nonconforming use. Discussion ensued. There was talk about the definition of dwelling. The Commission decided that Ms. Johnson should submit a zoning permit for Renovations at 292 Mountain Road and write on the application that no kitchen will be added.
 - B. Discussion Regarding Family Compounds/Camps in the Zoning Regulations. Continued to next meeting.
 - C. Discussion Regarding Junk & Unregistered Vehicles in the Zoning Regulations.
Stacey Sefcik has had complaints about unregistered motor vehicles. Ms. Sefcik discussed the definition of junk yard. Ms. Sefcik discussed perhaps having a blight ordinance in Norfolk, she said that Torrington has one. Ms. Sefcik and Commission members will do research on Blight ordinances and Ms. Sefcik will talk to Glen Chalder.
