**Beaver Control:** The NCC has requested the Beaver Institute to survey two sites – the town tennis court area and the intersection of Mountain and Westside Rds — where beaver flooding is causing problems.

**Review Procedural Guidelines:** Susannah distributed procedural guide-lines to NCC members. They will be reviewed at the May 12th meeting.
